#### <u>Summary of Activities and Results:</u> Principal development results:

\* Principal results or developmental change caused/stimulated/supported by activities (e.g. improved skills, enhanced knowledge, increased effectiveness, greater participation of women and youth in policy formation and decision-making) using performance measurement indicators from LFA for specific activity;

The powerpoint presentations on *Cidadania and Diversity* stimulated dialogue around the plight of Brazilian fisherwomen who are often subject to both gender and racial discrimination.

And since poverty also falls along gender and racial lines, fisherwomen find themselves amongst the poorest in the communities along the banks of the SF. Suggestions were offered to include fisherwomen and fishermen equally on the various councils set up or being set up in the municipalities to increase their role in decision-making and policy formation, beginning with a gender policy for each.

The gender manuals lodged in each municipality (Tres Marias, Pirapora, and Ibiai) and also with a select number of female leaders from Beiro Rio and Ibiai fishing communities, are resources for future activities and potentially will enhance knowledge.

The three translated OECD gender equality tipsheets are useful tools for municipalities and NGOs when mainstreaming gender into organizational policies and procedures (effective gender strategies, gender and the environment, as well as monitoring). These have the potential of improving skills and understanding appropriate questions to ask when dealing with genderrelated development issues.

The disposable camera initiative has the strong potential of enhancing the self-esteem of the fisherwomen. The resultant photo storybook, which will identify the significance of the picture content in their own words, could be useful for the fishing communities in having their unique perspective taken into consideration by the private, public and civil society sectors. A possible spin-off is that some of the photos and stories could be used in literacy classes in their own communities.

Knowledge of composting and using fish parts as fertilizer was enhanced by way of discussions.

#### **Unexpected results:**

Identification of the following opportunities for artistic expression that have the potential of raising the collective self-esteem of the fishing communities:

May 20<sup>th</sup> Fish Fest in Beiro Rio (potluck concept and potential for popular theatre/storytelling events on Nov.  $21^{st}$  – World Fisheries Day and March  $8^{th}$  – International Women's Day) - could be replicated in 5 other PPA areas. People from around the reservoir could be invited to bridge the agriculturalist-fisher divide. Farmers are potential purchasers of fish by-products (after filleting) for fertilizer and potential users of smoker for their cheeses. The *cumprade(s) d'agua* ghost stories seem to generate the most excitement and could become the thread the binds the SF river communities together. The *carranca* wood carvings become part of the story as well.

After meeting the Pirapora municipality, we stopped into the recently opened Institute for the Promotion of Cultural (Antonia Diniz Dumont) IPCADD in Pirapora, showcasing an embroidered quilt along the lines of community mapping of SF river (linking with IDRC ArteChico initiative & potential venue for popular theatre/storytelling events on Nov. 21<sup>st</sup> and March 8<sup>th</sup>). Farmers from Buritizeiro, Pirapora and Barro do Guiacui could be invited to facilitate linkages with the fisherfolk from the same areas.

While visiting the Ibiai municipality, it was determined that the venue would be ideal for mural paintings (4 walls in upper hall begging to be used---suggested themes with river & fish flowing through---four generations of children, youth, adults, elders). Potential unveiling ceremony and venue for popular theatre/storytelling events on Nov. 21<sup>st</sup> and March 8<sup>th</sup>). Agriculturalists from Ibiai could be invited to facilitate linkages with the fishing community.

### Quantitative indicators:

26 fisherwomen ranging in age from 22 to 70 years of age, with an average age of 38.6 years.

# government representatives from 4 municipalities (mainly female)

# representatives of NGOs (Vida, GRAAL)

# representatives of fishing colonies (mainly male)

### Qualitative indicators:

All 26 women were delighted to participate in the fisherwomen's photo storybook initiative and eager to learn to use a camera.

All 4 municipalities primed to include gender and racial diversity in their programming, and possibly on their thematic councils.

### **Relationship of results to PPA objectives:**

Relationship of these results to the objectives of Projeto Peixes Pessoas e Agua and terms of reference for the consultant;

The mission's overall objective was to propose appropriate gender-sensitive indicators for monitoring the well-being of fisherwomen and fishermen & fishing families, as well as the fish environment.

### Challenges faced and lessons learned:

\* Problems or difficulties encountered and lessons learned;

During interviews, sometimes the husbands, sons or neighbours would interfere with the fisherwomen's ability to freely answer questions.

### Activity planning and recommendations:

Existing plans and suggestions for follow-up activities.

Gender strategies:

Get 2 fisherwomen on municipal councils, especially the Women's Council, and seek out 2 gender-sensitive fishermen as well.

Facilitate the creation of a fisherwomen's association, for social and educational purposes, that unites women from the six communities along the SF river.

Work alongside local fishing colonies to target fisherwomen for training in deboning and filleting, as well as smoking, drying and fish fertilizer.

With the colony leaders, identify and assist fisherwomen 55 and over in need of retirement planning and securing government benefits.

Run anger management courses for fishermen, as well as substance abuse counseling. Promote the establishment of a Neighbourhood Watch program and/or a Women's Police Unit to deal with violence against women.

Ensure there is a Safe House in each community where women and children can go for assistance in case of emergencies.

### Diversity strategies:

Secure 2 spots for fishers (male and female) on all other municipal councils for gender balance. Promote the establishment of an office/secretariat for diversity issues and collect & disseminate disaggregated data based on gender, race and age.

Create a Task Force on Fisher Families in each municipality to review discrimination issues (gender, race and age mainly) and to coordinate assistance that cuts across programs.

Communication strategies:

Municipal councils to form libraries with access to information for the public---materials specific to gender et al.

Establish intra and inter-institutional network to make the most of what is available in the community.

Develop a directory as a tool for public awareness-raising about government, private sector and civil society resources for fishing communities.

## Recommended gender workplan:

### July:

Week 1 – Thais (& Sarah?) river trip to pick-up 26 cameras (develop in Pirapora) and then drop off one set with women while obtaining stories of each photo & getting signed release forms (Ibiai, Barro do Guiacui, Pirapora, island and river people, Beiro Rio).

Week 2 – Finish outstanding reports. Organize photos and stories, group into themes, and explore publishers such as IEF.

Week 3 – Explore establishment of NGO and draft potential by-laws. Make link with Penedo group at the mouth of the SF.

Week 4 – ArteChico assistance if required.

## August:

Week 1 – Planning 4 Action Planning Workshops and making logistical arrangements.

Week 2 – To SG with bus load of women from Beiro Rio to raise their issues with Mayor & Councils

Week 3 – Ibiai workshop on Mon/Tues; Wed off; Pirapora workshop on Thurs./Fri.

Week 4 – Tres Marias workshop on M/T; Wed. off; SG workshop (R/F)

Week 5 – Complete monthly field activity report including workshops, as well as expense reports.
